Farningham Parish Council met in the Shand Hall at St Peter and St Paul's Church on Wednesday 10th September 2025.

PC Collins and PC Guest.

Our local Beat Officers reported that they are aware of the weekly motorbike meets at the A20 layby opposite Scratchers Lane. Officers regularly attend, which has resulted in less antisocial behaviour and dangerous riding however, the issues of dangerous road use and antisocial behaviour is still ongoing. They are continuing to explore long-term solutions. PC Collins and PC Guest explained that the routes they patrol during their shifts are based on data from reported incidents. They stressed the importance of reporting all incidents, no matter how small, as this information determines where and when their presence is most needed.

SDC's Local Plan:

By the time this report is published, it is likely that Sevenoaks District Council will have released information regarding the third Regulation 18 consultation for the emerging Local Plan. SDC's Development and Infrastructure Committee will be discussing the plan at 7pm on Tuesday 23rd September and it is likely that the plan will be discussed again by SDC's Cabinet who are due to meet at 7pm on Thursday 9th October. The agenda for each meeting

will probably include potential housing development sites that have been identified for the consultation. There is a public viewing gallery at SDC's offices in central Sevenoaks, and a live YouTube channel if anyone would like to observe the meetings, https://www.youtube.com.

We expect the Regulation 18 consultation to run from late October to early December and we believe another pop-up event will be held in one of the villages in November, allowing residents to attend and ask SDC officers and Committee members questions in person. We will share further updates as soon as we receive them and encourage everyone to respond to the consultation once it is open.

Neighbourhood Plan:

Thank you to everyone who returned the first Householder Questionnaire. The Steering Group is currently working through the responses, which will form the foundation for the policies that are developed helping us ensure that the plan is shaped by the community from the very beginning, and reflecting local priorities.

A more detailed questionnaire will be released at a later stage to gather information specific to each policy that is identified and is essential to developing an effective and evidence-based plan.

FPC has appointed a consultant who will start to work with the Steering Group straight away.
